DESCRIPTION (field, expectations, comments):

The Chair for Philosophy of Science at the Institute of Philosophy (Warsaw University) engages in educational and research activities in the field of philosophy of natural sciences and analytical ontology. The employees of the Chair run courses for philosophy students (in Polish and in English) in ontology, philosophy of natural sciences (physics, mathematics and biology), general philosophy of science (as optional course), logic and set theory (for philosophy students and for students of cognitive science). The employees of the Chair also offer seminars and lectures in philosophy of physics, philosophy of mathematics, philosophy of biology and in the field of general ontology issues. The research activity of the Chair concentrates on issues such as: philosophical and ontological questions of mathematics (discussion over mathematical realism and the question of the status of mathematical proofs), philosophy of biology, including meta-ethical questions connected with evolution theory, general ontological questions, such as the problem of identity and the continuity of existence in time, personal identity, causality and mind-body relation.

Expectations from the candidate:

The candidates are expected to have achievements and scientific interest corresponding with the research profile of the Chair of Philosophy of Science, especially in the field of philosophy of natural sciences and analytical ontology. Candidates specializing in the philosophy of biology will be preferred. Candidates should have a record of publications (domestic and international; in form of books and articles) proving their scientific interest in the filed sketched above. International experience gained during scientific exchange, international cooperation and participating in international grants will be of value. Candidates should be very well prepared to run academic courses in Polish and English. Candidates will be expected to run courses in ontology, philosophy of natural sciences and general philosophy of science and also to hold seminars and lectures dealing with questions of their personal scientific interest. The ability to acquire external funds for scientific research (including research grants) will be valued high.
