### DESCRIPTION (field, expectations, further remarks):

The Chair for Logic at the University of Warsaw conducts research activities in the field of: (1) logical pragmatics and methodology (the role of context in logic and its applications in relation to natural languages, inferences with incomplete information, logical errors, criteria for rationality of inferences, heuristics, representation of knowledge and information, the role of questions in the theory of conversational implicatures, counterfactual conditionals); (2) formal logic and its applications in philosophy and science (non-classical logics, theory of truth, proof theory); (3) philosophy of logic and mathematics (ontological and epistemological assumptions in foundations of logic (philosophy and logic in the Lvov-Warsaw School, philosophy of Kazimierz Ajdukiewicz).

Courses (both mandatory and elective) are given in the field of logic, set theory, methodology, philosophy of logic and the applications of logic in philosophy for the students of philosophy, cognitive science and also at the general university level. The didactic obligations of the Chair are quite extensive and heterogenous (among others, practical logic courses are given for the students of humanities and social sciences without any prior logical or philosophical preparation).

## Detailed requirements and the method of evaluation of candidates:

The evaluation of candidates will follow the recommendations formulated in the Statute of the University of Warsaw, the European Charter for Researchers and guidelines of the Rector of the University of Warsaw regarding the principles of employing entry-level researchers as assistants in an open competition. Candidates are asked to fill in the questionnaire (attached), which will allow the Commission to assess the relevant aspects of the Candidate's current academic and didactic activity in accordance with the recommendations given in the aforementioned documents.

Candidates for the competition at the Chair for Logic at the University of Warsaw should have a doctorate in philosophy (or related sciences) as well as scientific achievements and interests corresponding to the research pursued at the Chair for Logic. Candidates whose interests concern formal logic and the philosophy of logic will be given preference. International scientific achievements will be viewed as an asset, as well as the Candidate's additional formal education in science and mathematics. The Candidate's scientific interests should be documented by publications, conference talks and participation in research projects (see the questionnaire). The Candidate is expected to have a very good command of Polish and English, with the competence and readiness to conduct, among others, the following courses: 'Logika i teoria mnogości II', 'Teoria obliczeń' (at the Institute of Philosophy) and 'Logika' (at the Centre for Europe UW).

The candidate must fulfil requirements specified in Art. 114 paragraph 6 of the Act on Academic Education of 27 July 2005, Official Journal No. 164 item 1365 with further changes.
